- Brian Zilm (Congresswoman Budzinski) announced that the Congresswoman will be hosting a town hall in Chatham next month.

- Ryan Croke noted that there is real threat to Medicaid unfolding from events at the federal level
 and the Department of Healthcare and Family Services is concerned about the impact this will
 have statewide and on medical hubs like Springfield. The State is committed to advocating for
 people who rely on Medicaid.
- Steve Welch (Representative Scherer) noted that Representative Scherer can be available for meetings and activities within the district and encourages the Commission to reach out to the Representative as opportunities present.

 Miriam Wallace (UIS) notes that in addition to the patients who would experience immediate harm from reductions in Medicaid, the families and caregivers will also experience adverse impacts.

- Project update on Hope Springs Phase 2, presented by Ashleyn Daniels from North Arrow Partners & Mark McHugh from Envision Unlimited. This project will increase the number of supportive housing units in Springfield. The first phase of the project was at 9th and North Grand. The second phase will be located at 848 N. 9th Street and have 24 studio units with laundry, parking, and community spaces available.
- STREMSTERFER asks if there is anything the Commission can do to support the project. Mark McHugh asked the Commission to share the positive impact that of the first phase of the project and encourage support on the proposed second phase.
